



COLLECTED COURSES OF THE ACADEMY OF EUROPEAN LAW WORKSHOP WITH THE AUTHORS:

Contemporary Challenges to EU Legality

The 2018 Academy of European Law summer course on the Law of the European Union focused on the theme of contemporary challenges to EU legality.

Five Specialized Courses taught by prominent scholars in the field, identified and assessed the ways in which EU actions and norms can challenge legality, and considered the pathways taken towards or away from EU legality by EU institutions. They explored the production of norms by EU institutions and institutional arrangements/safeguards for legality in norm production, implementation and enforcement. They also examined adjudication of legality of EU norms as a central legality safeguard.

As well as providing theoretical overviews of how we can conceive of EU legality, the Academy summer course lecturers have explored further ways of examining how legality challenges arise and are accepted or challenged. These involved an examination of discrete areas of EU law where there appears to be strong evidence of developments challenging legality: EU asylum policy, Common Foreign and Security Policy and Brexit. A further cross-cutting theme entailed consideration of the extent to which accession to international instruments does, can and should act as an EU legality constraint.

In addition, a Distinguished Lecture delivered during the summer course addressed the theme of rule of law backsliding in EU Member States. This was concerned with rule of law challenges within the EU and considered how the EU can respond to domestic challenges to the Rule of Law.

This Workshop brings together these scholars to discuss and debate their draft chapters for the Collected Courses volume that will be published from the courses: Contemporary Challenges to EU Legality. Discussants will comment on the draft papers.
